Article III. - Membership

- The member will have the right to enjoy all the benefits of membership according to the type of membership chosen for the duration of their membership. ICAN will email the member immediately after the member's membership is established to inform them of the methods of drawing benefits and applying for discounts or study options.
- 2. An individual becomes a member of ICAN on the date that he/she confirms (agrees to these terms and conditions as part of the membership subscription), and ICAN receives the membership fee in the amount of the membership type selected (https://icanconnection.org/membership/). If a member chooses to pay the membership fee monthly, ICAN offers the convenience of setting up automatic payments from the member's payment card. The member just checks the appropriate box on the payment form. By doing so, the member permits ICAN to charge membership fees to the member's card regularly, with the help of the card's issuer. Of course, the member can revoke this authorization at any time according to his/her needs.
- 3. Duration of Membership: Membership is contingent upon adherence to ICAN values and payment of dues according to the membership type selected.
- 4. Termination of Membership: Membership shall terminate when a member revokes his/her acceptance of these terms and conditions in writing (including by email to ICAN) or defaults in paying membership dues. If the member chooses to terminate membership within 15 days of payment of the first membership fee, ICAN will refund the full amount paid.
- 5. ICAN may terminate membership if a member fails to pay membership dues on time or significantly violates any provision of these membership terms. Any such termination must be in writing (including e-mail) by ICAN. An ICAN member shall not be entitled to a refund of part or all of the membership dues if membership is terminated for failure or substantial breach of any provision of these terms by the member.

Article IV. ICAN - sponsored study opportunities for members

- 1. As part of its mission, vision, and activities, ICAN offers, among other things, tuition reimbursement for members (sponsorship) at selected partner professional educational institutions and schools.
- 2. ICAN does not directly offer any degree programs; instead, these programs are provided exclusively by professional training institutions and universities sponsored by ICAN. In addition, ICAN does not hold any ownership interest in, nor does ICAN as an association participate in, the management of these sponsored professional training institutions or universities. ICAN only sponsors (pays for the member's) studies as part of its activities.
- 3. This optional membership benefit is conditional on choosing a membership type that offers this option.

- 4. If a member has chosen a membership type that includes the option of sponsored (paid by ICAN) study at partner institutions, the following additional membership conditions apply:
 - a. The member hereby declares that he/she meets the criteria for admission to the selected program or course under the terms of the sponsored study. Suppose a student is found to have been admitted to a program based on false information provided by the student. In that case, this will be considered a severe violation of the provisions of the terms of membership.
 - b. If the member does not default on payment of the membership fee according to the type of membership chosen, the study will be sponsored (paid for by ICAN). If the member defaults on payment of the membership fee, ICAN must inform the partner institution or school, which will discontinue the provision of studies to the member.
- 5. The specific terms and conditions of the chosen study are set independently by the institution or school and cannot be influenced by ICAN.
